# 5. HOUSING REPORT UPDATE / FEEDBACK FROM DATA ORCHARD

- 5.1 Reviewing the response from Karla Johnson Herefordshire Council from information she had received from various department planning managers regarding proposed sites A and B the Steering Group concluded that a third site C should be taken into consideration. It therefore may be necessary to review the proposed Settlement Areas.
- 5.2 It was agreed that Data Orchard would carry out further investigation on site B.
- 5.3 Steering Group / Data Orchard reassess the weighting elements to sites A and B.
- 5.4 It was agreed to hold informal meetings with the agents of sites A / B and C with G Litson plus one other Steering Group member attending together with the Administrator. Steering Group members to provide the Administrator with the site agents contact details in order to arrange the meetings.
- 5.5 Submit the latest proposals to Karla Johnson Herefordshire Council for comment.
- 5.6 It was agreed that the draft Housing Report as it stands will now include either site A or B or C.
