5.4 Achieving the housing target for 2011 - 2031 and the table of housing breakdown is vital within the report together with the housing types / numbers that need to be decided by the Group relative to realistic site development availability.

5.5 The meeting was minded of the advice from Data Orchard that windfall sites should not be a part of the housing numbers but used as a cushion.

5.6 The Group need to check with Data Orchard / Herefordshire Council present planning applications expected to be approved.

5.7 Group members need to review potential barn conversion possibilities in the Parish.

5.8 S Borthwick will determine the historic farmsteads in the Parish.

5.9 S Borthwick will investigate section WG 16 of the Plan – Protecting Heritage Assets.

5.10 G Litson and the Parish Council Group Chairman will determine surface water run off from fields through discussion with the Parish lengthsman.
